Notice of Proposed Amendment, Creation and Abolishment of Positions

RE: Computer Positions under the Office of Technology

Buenas yan Håfa Adai! This memorandum respectfully requests approval to amend the current classification specifications and position titles for the positions listed below, at the request of the Chief Technology Officer, Office of Technology (OTECH).

The proposed amendments to the class specifications are intended to update the standards to reflect changes and advances in information technology (IT) and the technical infrastructure used across all executive branch agencies of the Government of Guam. Additionally, the position titles have been amended to modernize them and align the associated duties and responsibilities with current IT terminology, as the existing titles are outdated. The current standards have not been updated since they were established in July 1980.

Public Law 34-76 established the Office of Technology as a separate agency of the Government of Guam with the authority to advise and make recommendations to departments/agencies on their information systems and have the authority to oversee coordination of the government's technical infrastructure. Updating the job standards will ensure alignment with current compliance requirements, IT policies and regulatory standards, and the evolving complexity of information systems, information equipment, telecommunications and cybersecurity measures.

The following is our recommended Hay Evaluation for the proposed amendments which will result in pay grade reassignments for all positions.

In addition to the proposed amendments, this memorandum requests approval to create and establish a class specification for an Information Technology Network and System Design Specialist position into the classified service. The request is based on a memorandum dated March 4, 2025, by the President, Guam Community College in collaboration with the Office of Technology.

The creation of this position is necessary to meet the demands of an ever-evolving technological environment and to establish standards for information technology (IT) and technical infrastructure. The role involves performing complex professional work in IT application systems and is critical to executing IT projects, setting goals, developing plans, and using industry-standard methodologies and tools to monitor performance, conduct risk assessments and ensure that goals and objectives are completed on time and within budget.

These positions are currently vacant and have not been filled for many years. OTECH has recommended that the following positions be abolished:

After the 10-day period has expired, the proposed job specification will be submitted to the Director of Administration and the Governor for final approval.
